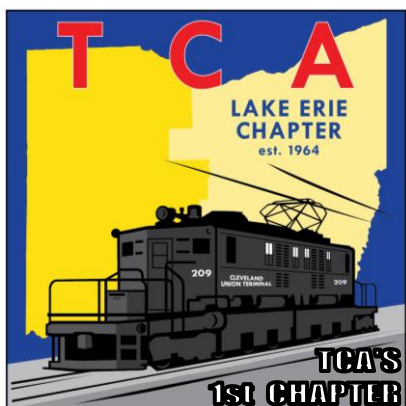

## **EVERYTHING IS NEW !!**

### **PLEASE READ COMPLETELY**

None of the buildings & parking lot we are using are being used by the NMRA show in October, So please follow these instructions:

Use **gate #2** on Eastland Road to enter the fairgrounds. Once you pass the fair office, turn left, the parking area (gravel surface) will be to the right. Some handicapped parking will be available in front of the arts & crafts building (north of the main lot). We will have signs on Bagley Road, Eastland Road, the parking area and the buildings to help guide you.

The Meet will occupy 2 buildings (Home & Hobby and Arts & Crafts).

You will be able to enter either building first. The admission tables will be inside the front doors. Pricing is the same as it was in Parma. TCA members and their families will get name badges, which will allow you access to both buildings. The public will get a hand stamp.

At the rear door of the Home & Hobby building a sidewalk leads to the west side door of the Arts & Crafts building. This will allow a short cut between buildings, but can only be used after you register at an admission desk.

Food & drink will be available in the dining area at the rear of the Home & Hobby Building. This is being provided by a licensed food vendor with a mobile kitchen, as there are no cooking facilities in the halls.

# **FOR OUR DEALERS EVERYTHING IS NEW AS WELL !!**

### **PLEASE READ COMPLETELY**

This is only the 2<sup>nd</sup> TCA Meet at this venue. We will work with you to find a table location to your liking.

We will split the dealers evenly between the 2 buildings, as well as the layouts & displays

None of the buildings we are using are being used by the NMRA show in October. So, if you set up at that show, you cannot be in the same building or location at our show.

Enter the fairgrounds as described in the section above.

All load in /out doors are at ground level. You may park at these doors **ONLY** to load in /out.

**You will be shown where you may park after you unload.**

The tables will be arranged the same as in Parma. The perimeter tables will be against the walls, with dealers working in front of their table(s) and all other tables will be in double row columns, with the dealers behind their table(s). Please specify if you want to be in a row or along the wall & if you want to be next to someone.

To maintain current pricing, all dealer spaces will be in 6 foot lengths, regardless of the table length. Tables will be marked off as such, with your name on your spaces.

When you come to set up, report to an admission table. You will be given your table assignment and escorted to your location. We will show you your spaces and the nearest load in / out door.

**YOUR NAME TAG** must be filled out and worn at all times.

**DISPLAYS WILL NOT EXCEED A SHELF HEIGHT OF 6 FEET FROM THE FLOOR**

**ALL ITEMS OR DISPLAYS WILL BE ON THE TABLE SURFACE OR DIRECTLY BELOW THE TABLE**

**TABLES WILL NOT BE MOVED FROM THEIR LOCATION SET BY THE TCA LAKE ERIE CHAPTER**

**MARKING ITEMS ON TABLES:** All must be marked DISPLAY, TRADE, or PRICED

**REPRODUCTION/REFINISHED ITEMS:** By attending this meet, you agree that all items sold by you at this meet shall be sold on the basis that you represent all such items as authentic, in the manufacturer's original condition. If any item you sell is not in original manufactures condition or is a reproduction, it shall be appropriately marked as a repair, restoration or a reproduction. Standards Committee representatives will be at the meet. In the event of disagreement as to whether an item is actually refinished or a reproduction, the decision of the meet officers shall be final. Rectangular orange labels will be available.

**ALL OTHER LAKE ERIE CHAPTER RULES WILL BE ENFORCED**, including tables must have merchandise on them until 3pm

### DIRECTIONS

#### FROM I-90

**Eastbound:** Exit #170B to I-71 (south)  
or

**Westbound:** Continue to I-71 (south), proceed to exit #235, Bagley Rd. turn right (west) 1.2 miles, turn left onto Eastland Rd (south) .4 mile, Gate 2 on left

**FROM OHIO TURNPIKE:** Exit #161 to I-71 (north)  
exit #235, Bagley Rd. turn left (west) 1.2 miles, turn left onto Eastland Rd (south) .4 mile, Gate 2 on left

**FROM I-71:** Exit #235, Bagley Rd. turn (west) 1.2 miles, turn left onto Eastland Rd. (south) .4 mile, Gate 2 on left

**FROM I-77:** Exit #156 to I-480 (west), then follow directions from I-480 or Ohio Turnpike (west) to exit #161, I-71 (north), then follow I-71 directions

#### FROM I-480:

Exit #11, I-71 (south) to exit #235 Bagley Rd. turn right (west) 1.2 miles, turn left onto Eastland Rd. (south) .4 mile, Gate 2 on left
